

# PETITION

We the undersigned Citizens of the State of North Carolina do hereby Petition all Members of the General Assembly of North Carolina, both North Carolina House of Representatives and North Carolina Senate; Governor Michael F. Easley; and Lieutenant Governor Beverly E. Perdue; as follows:

To cease and desist from all actions and contemplations to violate the North Carolina and United States Constitutions by the unlawful seizure of property rights by taking Private Property Well Water Rights by placing meters on Private Property Wells and measuring consumption or limiting consumption or charging fines and fees.

To make collective and individual statements stating intentions to cease and desist and denounce unlawful taking of Private Property Well Water Rights referenced in number 1 above by April 15, 2008.

To cease and desist from actions and contemplations of Private Property Well Water Rights during the Short Session from May to July of 2008 and refrain from actions on controversial issues unless in full session.

To hold Public Hearings in each County of the State of North Carolina previous to any contemplations by the General Assembly of taking Private Property Water Rights with mandatory attendance at the meeting of the North Carolina Governor and Lt. Governor; Speakers of the North Carolina House and Senate, and North Carolina Representative and Senator for each County.

To make notice of the Public Hearings in such a way that the People are notified with due time to attend and in such a way that they are notified and the notice is not merely a gesture to comply.

To acknowledge the service to the Community at large by Private Property Well Owners who supply their own water and waste treatment systems thereby decreasing the burden on municipal water systems and who pay Property taxes to help supply water to those Citizens without Private Wells.
